OUR LAST MEETING

Was held at the Petite Auberge Restaurant in the Tocco Hills Shopping Center. We had a crowd of probably 65-75 there, including all the regulars and we had some guests. The meeting was on June 15. Jim 'arroll presented the Teeasurer's report, whowing a balance of \$1,008.31, including \$485+ in a savings account. Eriksson talked about the motion he made to donate \$500 to the SAF Memorial Fund, which was passed at a previous meeting, but which was reduced to \$300 by the Board because of that amount having been set up in the budget for donations. Herrick discussed the Constitution and pointed out the status of membership; duties of the Board and other items of interest. He discussed the motion made at the previous meeting and mentioned that the Board agreed to donate \$300 only because it was the amount set up in the budget; the higher amount would have wiped out the savings account, but also called attention to expenditures not set up in the budget. No further action taken. Huber read a letter from S.A.F. commenting and thanking us for the contribution. There was a question raised as to why members who had died prior to 1976 were not mentioned for recognition in the Memorial Fund, stating that we should honor all of our deceased members. He also took exception to the awarding of a plaque to the past president, calling attention to the setting of a precedence. Eriksson introduced

the speaker on the program. He told us about various personnel changes; retirements the new administration; wildlife areas; court cases; executive orders; Landmark Legislation of Management Act: the Cross Channel Barge on the Ocala; sealed -vsoral bidding on timber sales; application topermit mining coal on the Jefferson owned by third parties: National Conservancy into Standing Indian Area; appeal on off-me road vehicles in N. C.; Alaska Debate; law suit in Texas - no sale of timber; government presented a good case with experts etc. a good judge and a good case. with decision against the F. S. but we have a good chance of appealand the case was going to be appealed and it would be up to the Judge-optomistic about it.
