OUR LAST MEETING

Was a luncheon at Petite Auberge Restaurant. Our President opened the meetby introducing guests, which included our program Larry Whitfield, Regional Forester, and John Vance, S.E. Area Chief. Also Roman Pheffer, Mary Mayer, Evelyn Phillips; Eriksson's guests June & Mike Motel and the Gainesville group George Hoffman, Bruce Alter and Brooke Davis and their wives. Our Treasurer. while reporting us as "broke" reported a balance of \$1159. Reports given about Polly Brandt being in the hospital; A.W. Hartman being home again from the hospital; the death of Dorothy McMurtrie's husband; Olga Rossoll being under the doctor's care and Harry having an excuse to miss this luncheon. A report by ye-ed on the FS-X picnic on April 19-with invitations extended by Bill Irby & Don Morriss for our members to attend. Rip Williams gave an excellent legislative report in connection with the programs in Congress. Larry Whitfield and John Vance gave us a good report on what is going on in the Forest Service and S&PF. The retirement of Joe Couch; Roy Bond and Rex Dressler was announced. I think it was Larry Whitfield who told a tale about a fishing rod given to him by Bill Branch a long time ago and indicated he had spent 35¢ maintenance since then. Dorothy Smith was in charge of door prizes, assisted by Roman Pfeffer, and Bill Fischer, Mary Meyer, Doug Craig, Lew & Helen Whipple, Lida McKenzie, Judy Grumbine, Walt Gray and Lucille Isbell were the winners. Walt Gray ought to go to Las Vegas and try his luck-he wins a door prize each time.

Readers of the DIXIE RANGER might be interested in an update on our history activities, especially since so many of you are active participants in the program. Approximately 50% of our historian's time is devoted to our oral history program. To date, we have eleven tape recorded interviews with R-8 pinneers. The interviews consist of the narrator's recollections of his F. S. work in the Southern Region with emphasis on interpretation of facts. Our roster of interviewees include such familiar and respected names as: Arthur W. Hartman, former assistant regional forester in charge of fire control-a "Yankee fire exclusionist" who came down South and became a "born again" advocate of prescribed fire; Gaylord "Lum" Knight, the first and, for many years, the only communications/electronics expert in the entire region, and Harry Rossoll, the Region's first illustrator and Smokey Bear artist. The other half of the history effort is directed toward the production of a written interpretive history. Art Hartman is acting as collaborator, and has assisted the historian in developing an outline. Chapter one, an introduction and overview, is almost completed. Subsequent chapters will address in detail such topics as land acquisition, the impact and contributions of the CCC, the emergence of planned use of fire and the development of state and private forestry organizations. On the administrative side, all the historical materials on hand have been organized. A tape cataloging system and outline format have been developed, along with a phoeo cataloging system with cross-reference to the tape recording. Several of you have responded to our request for written memories. Excellent manuscripta have been received from Norman Hawley, Arthur Grumbine, Jack Wellhorner and Dorothy Robinson. We are grateful to these retirees, and to others, who have sent photographs and given us "leads" on additional sources of information. Although personal thank-you's have been sent to each retiree who has written us, we appreciate this opportunity to thank you publicly. And that is where the program stands now. We feel good about the progress that has been made, but anxious and impatient to see more information pulled together. I'd like to add that at many points the program would have faltered and perhaps failed without the contributions of retirees. We certainly need your help - and many of you are responding by giving freely of yourselves in time and effort.

MARCH 23, 1979 THE FRIDAY NEWSLETTER: REORGANIZATION: In response to our inquiry requesting clarification on the date the President will submit his reorganization plan to Congress, the chairman of the White House Reorganization Working Group for press matters, said that now they expect to submit the plan in May. Previous administration statements had indicated that the plan would be sent to Capitol Fill in Late March-early April.

2,4,5-T USE ON RANGELANDS: The environmental Protection Agency (EPA) in their 3/1 emergency suspension of 2,4,5-T and silvex use, did not suspend the use of these products on rangeland, including noxious weed control. Dr. Cutler has informed that the F. S. can continue to use 2,4,5-T and silvex as long as we follow the project selection criteria approved on 2/13.

FROM OPEDA NEWSLETTER: By the time you read this, the President probably will have signed into law the Civil Service Reform Act of 1978. Mike Causey's Federal Diary Column in the Washington Post is quoted: "If the system works well, it should mean the best people will be rewarded for being good managers, and the mediocre or average managers who now get longevity raises simply for remaining alive will get minimum increases. If the system is abused, perish the thought, and favoritism rears its ugly head, it will mean unfair or politically minded bosses will have a new pipe-line into Pederal cash register to reward their friends and punish the less cooperative. Perish the thought."

ALSO from OPEDA - something about "flex-time". Employees can now choose their time to go and leave work. They can work alternate 4-day and 5-day weeks. Work days can be 9-hours and average 40-hours a week, giving them 26-three day weekends a year. Another plan calls for a 10-hour day and 4-day week week. (How about some of you retirees who worked each week end and, sometimes, all night when the woods were burning on the forests where you worked?)

LETTERS FROM OUR MEMBERS

Our daughter Barbara was injured in a fall while returning home from school. Her spinal cord was severed at the second vertebrae and she was totally paralyzed from her arms down. For 34-years she has been confined to a wheel chair or to bed. The past seven and three fourths years she has spent almost all of her time in bed. During the 34-years she has spent more than 2500 days in hospitals. She has undergone twenty seven major surgical operations and many minor ones. In spite of her handicap, she graduated from the U. of N. C. at Chapel Hill and was the first woman to graduate from a wheel chair. She is cheerful and an inspiration to all who knows her. Barbara has three brothers and two sisters and all have college degrees. We are a close knit and happy family. My wife Vi and I have eight grand children and one great grandchild after 45 years of married life. I retired in 1970 but still work part time. I am active in church work and am now in my 31st year of teaching an adult class. My hobby is collecting uncanceled U.S. postage stamps, which I started collecting more than forty one years ago. My physical health leaves much to be desired but I am quite happy and life has been good to me. Here's \$2 for membership.
