BOARD OF DIRECTOR'S MEETING

Held on June 6, 1973, with the following in attendance: Herrick, Fischer, Whipple, Russell, Eriksson, Thompson, Adams, Grumbine, Newcomb and Hunt.

Purpose of the meeting was to consider three items of business (1) Plans for the next several meetings (2) Consider requests for special membership (3) Finalize plans concerning postage situation.

Whipple reported on (3) that all papers have been submitted to Internal Revenue Service and their approval of non-profit status to Association is expected. Whipple will make final check week of June 11.

Herrick furnished names of non-eligible persons who wanted to join Association, including Dr. John Lippert, Chuck St. Lawrence, Jack McElroy, Stan Adams and Walker Newman. Newman qualifies as to membership. Decided, since the others wanted membership only for being on mailing

list for Dixie Ranger, that they would be placed on SUBSCRIBER LIST and mailed Dixie Ranger on payment of regular fee of \$2.00 per year.

Information about the next two meetings will be covered as separate items later.

Whipple suggested making assessment of nominal fee of 50¢ or \$1 to those who attend annual picnic, to offset cost of furnishing various items, such as soft drinks, cups, plates, coffee, etc. Decided that at future picnics, a cigar box or other suitable container would be set up with a "contribution" sign attached and anyone who wanted to contribute towards defraying cost could do so. The contribution is not mandatory.

Considerable discussion of membership, particularly widows of deceased members. It was general consensus that widows may continue as members by paying the \$2.00 membership fee. This is according to the Constitution.

Considerable discussion about non-payment of dues. Treasurer read a list of those who, according to the record, had not paid dues. Some of those on the list had not paid for either 1972-1973. It was agreed that we continue to advise those who have not paid by "rubber stamp notice" on their copy of the Dixie Ranger.

It was also agreed that in the final newsletter of the year, at which time you will be dunned for 1974 dues, that a form

containing the correct information as to how to pay dues, will be made a part of the newsletter. The reason for this is because (1) checks and cash are coming in with no identification (2) are being sent to various offices and individuals (3) we have evidence that some of the checks for dues have found their way to the Fiscal Agent's office and have been deposited in the Treasury of the U. S. Checks should be made payable to Southern Forest Service Retiree Association and mailed to the address on this letterhead. Payments by cash should be identified as to sender.

The following excerpts are taken from a news article "U. S. FOREST SERVICE - TRIBUTE TO SEELY". Ted Seely, District Ranger on the Pisgah Ranger District for 14 years, passed away last Thursday. Ted's accomplishments and marks on the Pisgah NF in Transylvania County will remain for many years. He was instrumental in establishing the Cradle of Forestry in America, the birthplace of Forestry and Forestry education in the United States. Ted also worked hard in establishing the Schenck Job Corps Center. He also was instrumental in getting a better road from Rosman through Balsam Grove to Lake Logan (Hwy. #215). He was the first Ranger in the U. S. to initiate a law enforcement night patrol in order that campers would have a safe and enjoyable experience in the N. F. Ted married Jean English, a native of this county, raised two sons and then retired in Brevard. During his retirement, he never interfered with District operations, but was always available for

consultations and advice, according to D. R. Dan Hile. Also, according to Dan Hile, Ted Seely will be missed, but his many contributions to the National Forests will remain.
