TREASURER'S REPORT

For the year, December 1971 through November 30, 1972, the Treasurer accepted deposits of \$624 and issued checks for \$502. Neither figure includes funds for the Cradle of Forestry bus trip which were handled through the Treasurer, as a matter of convenience, but at no cost to the Association. In February \$380, from 1971 dues, were placed in a savings account, available upon demand.

The \$502 was spent as follows: Publication of the Dixie Ranger & 1972 Directory \$191.; Postage \$122.; donation to the American Forestry Association in behalf of the Cradle of Forestry Association \$100.; Stone Mountain picnic \$49 and Miscellaneous \$40.00.

Twenty-one members paid their '72 dues twice and John Cooper wrote some of them in August stating the extra payment would be applied to their 1973 dues. Twenty other members paid \$4 or more. Just for the record, the following members paid their '73 dues on or before 11/29/72.

BUDGET COMMITTEE - A. A. Grumbine

Budget submitted in the amount of \$387 for the year 1973. The bulk of this covered the printing, mailing, etc. of the newsletter, plus amounts to be set aside for luncheon payment for our speakers and floral arrangements for our luncheons.

PROGRAM COMMITTEE - Eriksson-Russell

This report was a summary of programs for 1972, plus what might be undertaken in 1973. It was the consensus of most of the members that the overnight bus tour and annual picnic be continued as an annual affair of the Association.

NEWSLETTER COMMITTEE - Hunt

Contained a summary of newsletters issued in 1972, plus a plea to members for help in getting material, especially letters from out of town members, for inclusion in future letters. Stressed lack of communication in obtaining information concerning deaths of members, particularly those occurring away from Atlanta.

LEGISLATIVE COMMITTEE - Huber

Bill Huber submitted a detailed report on legislation affecting the Forest Service nation wide. In his report, Bill stated that the Forest Service fared quite well in the 92nd Congress, which came to a close on October 18. Actions in the plus column far outweighed those on the minus side.

D U E S of \$2.00 per year for 1973 are now due and payable. The Constitution establishes the date of March 31 as the deadline for paying dues for the current year. The penalty for failure to pay dues is that member be dropped from membership in the Association. (Ed's note: I kind of feel that the Dixie Ranger, alone, is worth \$2.00 a year. Hope you agree with me.)

BOARD OF DIRECTORS MEETING

Our first meeting of 1973 was held on January 3 at the home of President Clint Herrick. Members or representatives present were: Herrick, Fischer, Whipple, Cooper, Evenson, Eriksson, Grumbine and Newsletter Editor Tom Hunt.

Eriksson gave a report of his investigation of costs of postage for our newsletter. The Board decided to go ahead and obtain a special permit from the P. O. Department, which will enable us to send out the newsletter at a cost of approximately 1.7¢ per piece. This will be a considerable savings over what we have been paying, even taking into consideration the initial fee of \$30.00 plus the annual fee of \$15.00.

Eriksson also gave a report on his discussion with the Regional Forester concerning entering into a cooperative agreement with

the Forest Service concerning assistance in reproducing, collating and addressing our newsletter. This is being worked on now and we hope to be able to get into a cooperative relationship with the Forest Service on this, our most expensive activity.

Plans will be made for our next meeting, which will be discussed later on.

In planning future meetings, especially for June-July this year, there was considerable discussion. Here is what has been decided on for this year:

- 1. A luncheon meeting in Atlanta.
- 2. An overnight bus tour. A 4-day boat cruise to the Bahamas.
- 3. Annual picnic at Stone Mountain.
- 4. A November-December luncheon meeting.

In connection with #2 above the Program Committee would like to hear from members as to what THEY would like...prefer. The tour of the Cradle last June was excellent and everyone had a good time. Much interest has been expressed in a boat trip, which would involve a bus trip to Charleston, S. C. and a 4-day tour to the Bahamas. The cost would be reasonable. So let us hear from you as to what YOU would suggest as our mid-year meeting activity.

It was voted that the Constitution should be republished to take care of the several amendments already voted on and to include one or more that have been discussed by the Board. One of these is that the Vice President automatically becomes the next President, which will mean that in voting next year, you will vote only for one in the President's category, which will be for Vice President, with the current V-P becoming President automatically.

Much discussion was had concerning communication between our Welfare Committee and the Regional Office, in the way of trading information, particularly on deaths occurring among members and those still employed with the Forest Service. The Welfare Committee will work on this matter.

HEFFNER, Mrs. Kelly (Ruth), died on Dec. 29, 1972. A large number of her friends and relatives, and a good sized representation of the Forest Service attended her funeral on January 1.

MARTIN, Willie C.(Bill), died January 14 in the Veteran's Hospital. A large number of Forest Service people attended his funeral January 16.

SMITH, J. Roy (husband of Dorothy Smith) died January 10. He was buried on Jan. 12. Many Forest Service people attended his funeral.
